RE: CPC Application details for purchasing a Dock for Long Lake Beach

1. Project Description: Please give a detailed project description, including specific objectives.

The dock for the center of the lake should be updated in a similar fashion as the sailboat dock was updated with the Can Dock system in 2019. The current dock has large 3 foot by 5 foot sections that lock together and are held in place with metal poles. The plastic for the current dock blocks have cracks which allow water to seep in and propagate mold inside. Also the metal poles holding the dock in place are very rusty and difficult to remove after they have been pounded into the lake bottom. We have not installed the center dock in the last couple of years because they have gotten too heavy for our staff to lift out of the water once they are water logged. This section of the dock is important for safety purposes. First it physically creates a separation between zone 1 and zone 2, this allows the lifeguards to have a more specific area to focus on or to shut down one of the zones when there are smaller numbers of visitors at the beach. Second it creates a quicker response time to rescues in deeper end of the swim box. Additionally we would add on a fishing dock outside of the swim box and sailing dock. We have a large amount of visitors that fish and we want to be able to give them a space to do this safely without dealing with lost fish hooks and lures in areas where people are consistently in their bare feet. We are strongly suggesting the Can Dock System because it has 1 foot by 1 foot blocks that can easily be replaced at \$70.00 per cube and they can be placed into any configuration needed. If we use the same system for this section of dock it makes our overall maintenance much easier.

2. Goals: How does this project accomplish the goals of the Community Preservation Plan for Littleton?

This project meets the CPC goals by acquiring a new dock section that will help reach safety protocols for the lifeguards at long Lake. As mentioned in the previous section it creates a quicker response time to rescues in deeper end of the swim box and will create a two individual swim boxes instead of one large section to guard.

Additionally, it will allow us to achieve our goal of creating a fishing dock for our residents that have been wanting fishing access for many years. Giving them their own space will eliminate issues of people trying to fish at the swimming beach which is prohibited in the summer season.

This project meets the CPC goals by making steps towards preserving active recreation and enhancing a facility that is being use for active recreation specifically.

3. Timeline: What is the schedule for project implementation, including a timeline for all critical milestones? Will this be a multi-year project?

Once we receive funding for this project we will order the supplies needed and schedule a shipping and drop off date. We would hope to have this section installed and ready for use as quickly as possible to be enjoyed for the majority of the summer.

The total amount quoted for the materials and shipping needed is \$42,436.00. If there would be any funds left over they will be returned to the CPC upon completion of project.

- The Park Commission voted on 10/17/2023 to approve the purchase of the dock segments at Long Lake beach as the top priority for Fiscal year 2025.
- The Select Board and FinCom are supporting this project and the funding will currently be approved out of free cash at the Spring Town meeting.
