- **Discussion/Approval of Minutes**
  - Motion to approve May 15, 2025 Minutes. (Motion: Alan McRae; Second: Scott Glorioso). **Motion Passed: Aye Unanimous.**

- **Report of the Executive Director (ED)**
  - Mark reviewed monthly programming report from May.
    - Top On-demand/YouTube shows May – 1) LHS Graduation, 2) Select Board, 3) 01460 On the Go. Studio Usage: 10 hours; Edit Suite Usage: 16 hours.
  - Coverage of 8 LHS year-end events, including live coverage of LHS Graduation, recording of LHS Spring Sports Awards, and new coverage of LHS Financial Literacy Fair
  - Recorded & edited ATM Preview Show (noted that preview show had more views [288] than there were ATM attendees), and ground breaking ceremony for Shattuck Street.
  - Key assistance provided to Boxborough ATM, which went well.
  - LCTV Alternative Revenue Committee met June 3.
    - Discussed creating potential nonprofit. Mark researched with Friends of the Library rep Sarah Rambacher and shared a packet “Starting Your Nonprofit” with the Committee.
    - Analysis done to determine, if LCTV didn’t exist, what out-of-pocket cost would be to cover all meetings currently covered (cost would be >\$1M).
  - Mark shared his letter to the Select Board for approval of the Program Coordinator II position and a restructuring of the department. **Motion** for the Committee to recommend to the Select Board that changes are supported per the letter (Motion: Allen McRae, Second: David Astolfi). **Motion Passed: Aye Unanimous.**
  - Shattuck Street Center: Recorded first Select Board meeting from Center, which included School Committee, Planning Board, FinCom. Have AV rep from Shure (audio) on retainer starting July 1, if needed.
