**GREETINGS:**

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Littleton qualified to vote in the elections and Town affairs, to meet in the **Charles Forbes Kaye Gymnasium, Littleton Middle School, 55 Russell Street in said Littleton on Monday, the second day of May, 2011 at 7:30 o'clock in the evening** by posting a printed copy of this warrant, by you attested, at eight meeting houses, at the Town Office Building on Shattuck Street, at the Post Office at Littleton Common, at the Post Office at Littleton Depot, at the Baptist Church, at the Unitarian Church, at the Catholic Church, at the Congregational Church, and at the Mormon Church, in said Town, fourteen days at least before the second day of May, 2011, then and there to act on the following Articles:

To see if the Town will vote to rescind its vote under Article 4 of the November 14, 2006 Special Town Meeting which established an Ambulance Enterprise Fund pursuant to Chapter 44, Section 53F½ of the General Laws, or to take any other action in relation thereto.

**ARTICLE 4  
Board of Water Commissioners  
Capital Improvements #2 Well Production Facility**

To see if the Town will vote to raise and appropriate, transfer from available funds and/or borrow a sum or sums of money for the purpose of funding capital improvements to the # 2 Well Production Facility of the Town of Littleton Water Department, to improve well capacity and meet new MADEP drinking water regulations, or to take any other action relative thereto.
