**RE: Minor Stormwater Permit Application  
Proposed Retail Motor Fuel Outlet Redevelopment  
254, 256 & 260 Ayer Road (Littleton) and 0 Littleton Road (Ayer)**

The DPW has reviewed a minor stormwater permit application dated March 20<sup>th</sup>, 2023 for the subject project. Documents that were reviewed include:

- Stormwater Management Application by Greenman-Pedersen, Inc. (GPI) of Salem, New Hampshire, dated February 2023
- Site Redevelopment Plans by GPI, dated March 2023

The DPW **approves** the minor stormwater permit application, with the following conditions:

1. Following substantial completion of the project, an as-built plan must be submitted to Town of Ayer detailing all constructed stormwater infrastructure.
2. Provide Ayer DPW a point of contact for future on-site operation & maintenance of the proposed stormwater infrastructure. Completed operation and maintenance logs per GPI's stormwater management report must be submitted to Ayer DPW on a yearly basis for approval.
