This will serve to notify you, pursuant to 760 CMR 56.04 (3), that the above-named Applicant has applied to the Subsidizing Agency named above under the MassDevelopment Tax-exempt Bond Program for Multi-Family Housing for a preliminary eligibility letter for the above-referenced Project under M.G.L. c. 40B. The proposed Project is a rental project, with a total of 200 units, of which 40 units (20%) will be low income restricted for occupancy by families earning not more than 50% of the AMI for the area in which the Project will be located.
