We are writing to apply for a special permit/variance. Currently the front of our house sits less than 30 LF from Nashoba Trail. We have a walkway that comes directly up from the driveway to our front door, which is our main entrance and exit of the house. Currently when entering the house we do not have a place to hang jackets or put shoes. When you enter, the stairs are directly in front of you. We would like approval to add a 7' wide by 5' deep entryway mudroom. The purpose of this is to hang jackets and a place to sit down and take off your shoes. No other alternative is possible as we do not have room for a closet on the first floor. A certified plot plan is being prepared and will be submitted prior to the meeting.
