Edward G. Corliss

...of Littleton, retired from Bedford Air Force lab; 76

LITTLETON — Edward G. Corliss, 76, a longtime Littleton resident who worked nearly four decades in government service died Saturday, April 21. He was the husband of Hilda Dusti-Corliss and the late Theresa (Soulard) Corliss, who died in 1986.



He was born in Boston on July 7, 1924, a son of the late Edward and Mary N. (Carlin) Corliss. In addition to living in Littleton, Mr. Corliss also resided part of the year in Venice, Fla.

Mr. Corliss served in the Army during World War II with the 319th Company's 48th Replacement Battalion. He attained the rank of sergeant during his assignments in Northern France, Rhineland and Central Europe.

After 37 years of government service, he retired from the Air Force Geophysics Laboratory in Bedford. He was also a member of the Hanscom Federal Credit Union from 1960 to 1993.

Mr. Corliss was a member of St. Anne's Parish as well as a lifetime member of the Disabled American Veterans and the Chelmsford Lodge of Elks Lodge #2310.

In addition to his wife, he is survived by a daughter and son-in-law, Joan M. and Keith Nixon of Littleton; a grandson, Chad Nixon of Littleton; and four stepchildren, Kathleen Anderson of Galena, Ill., Carol Kenniston of Mustang, Okla., Jeffrey Dusti of Shirley and Barry Dusti of Wilton, Conn. He also leaves five stepgranddaughters; and a brother-in-law and sister-in-law, Francis McCarthy of Newbury, N.H., and Grace Soulard of Brighton in Boston.

Mr. Corliss also was the brother of the late Jean McCarthy.
