Good Morning Maren,

I understand Mr. Cataldo is scheduled to appear before the planning board this evening regarding 12 Robinson Road; Chief Clancy and myself have been in contact with Mr. Cataldo about the site. The proposed driveway for the two rear units does not meet fire code in terms of width, so it will be non-conforming; however, Mr. Cataldo has agreed to install an additional fire hydrant down by the two rear units to offset the non-conforming driveway, which is allowed by the fire code, if approved by the AHJ.

Given this information, at current, the Fire Department has no concerns regarding our access to all areas of the proposed construction at 12 Robinson Road.
