



CONSTRUCTION SEQUENCE:

1. CALL DIGSAFE A MINIMUM OF 72 HOURS PRIOR TO COMMENCING CONSTRUCTION ACTIVITIES AT 1-888-344-7233.
2. CONSTRUCT TEMPORARY AND PERMANENT SEDIMENT AND EROSION CONTROL FACILITIES. EROSION AND SEDIMENT CONTROL MEASURES SHALL BE INSTALLED PRIOR TO ANY EARTH MOVING OPERATION THAT WILL INFLUENCE STORMWATER RUNOFF.
3. CUT AND CLEAR TREES IN CONSTRUCTION AREAS ONLY.
4. RAZE EXISTING DWELLING AND ASSOCIATED STRUCTURES & IMPROVEMENTS.
5. CLEAR AND DISPOSE OF DEBRIS FROM CONSTRUCTION AREAS.
6. INSTALL NEW FOUNDATION.
7. BEGIN INSTALLATION OF SEPTIC SYSTEM.
8. CONTINUE WITH DWELLING CONSTRUCTION.
9. INSPECT SEDIMENT CONTROLS OFTEN AND REPLACE AS NEEDED.
10. INSTALL UNDERGROUND UTILITIES.
11. GRADE AND GRAVEL DRIVEWAY, WHICH SHALL BE STABILIZED IMMEDIATELY AFTER GRADING.
12. PAVE NEW DRIVEWAY.
13. COMPLETE PERMANENT GRADING, SEEDING AND LANDSCAPING.
14. REMOVE TRAPPED SEDIMENTS FROM COLLECTOR DEVICES AS APPROPRIATE AND THEN REMOVE TEMPORARY EROSION CONTROL MEASURES.





