Project Narrative

Project Narrative

Existing Conditions

The site is a 9+ acre lot that currently contains a single-family dwelling and appurtenances. Beaver Brook is located to the rear of the property and projects 200' Riverfront Area onto the parcel. There is Bordering Vegetated Wetland (BVW) located adjacent to Beaver Brook that projects 100' Buffer Zone onto the parcel. The property has been historically used as a gravel pit and therefore exhibits unique topography, with a prominent ridge located along the edge of the BVW and a gently sloping depression located in the approximate center of the parcel. The resource areas have been confirmed via ORAD, DEP#204-0987.

Project Description

The proposed project is the construction of a 3-lot residential subdivision. The proposed lots will be served by a 16'-wide roadway with a T-turnaround. A stormwater management system consisting of an infiltration basin, infiltration trench, and roof drywells for each of the proposed lots is proposed. Work proposed within the 100' Buffer Zone is for the installation of an outlet pipe from the proposed infiltration basin and associated tree clearing. A level spreader is proposed at the pipe outfall. There is no work proposed within the 200' Riverfront Area. A siltation barrier is proposed downgradient of the proposed work to prevent indirect alteration of resource areas during construction.

Resource Area Descriptions

The resource areas located on site include 200' Riverfront Area, Bordering Vegetated Wetland (BVW), and Bordering Land Subject to Flooding (BLSF). The resource areas have been confirmed via ORAD, DEP#204-0987.

Compliance with General Performance Standards for BVW 310 CMR 10.55(4)(a-e):

The General Performance Standards for a Bordering Vegetated Wetland have been met since the proposed activity does not involve removing, filling, dredging, or altering of a BVW.

Compliance with Town of Littleton Wetland Protection Regulations:

Proposed work within the 100' Buffer Zone includes the installation of a pipe outfall from the stormwater management system and associated tree clearing. All proposed work is located >50' from the edge of the BVW. Due to the existing topography within and outside of the 100' Buffer Zone on the property, it is not feasible to construct the pipe outfall outside of the Buffer Zone without substantial filling of the area draining to the proposed infiltration basin. No impervious surface is proposed within the buffer zone. A siltation Barrier is proposed to prevent indirect alteration of resource areas during construction. Any work associated with the development of the individual lots will require the filing of separate Notices of Intent.

Summary:

The project has been designed to meet the performance standards of the Wetland Protection Act. The project has also been designed to meet Littleton's Wetland Regulations. Erosion controls have been proposed to protect wetland resource areas during construction of the dwelling.

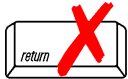

When a notice of intent proposes activity on a linear shaped project site longer than 1,000 feet in length, notification shall be given to all abutters within 1,000 feet of the proposed project site. If the linear project site takes place wholly within an easement through another person's land, notice shall also be given to the landowner. Said notification shall be at the applicant's expense, and shall state where copies of the notice of intention may be examined and obtained and where information regarding the date, time and place of the public hearing may be obtained. Proof of such notification, with a copy of the notice mailed or delivered, shall be filed with the conservation commission."

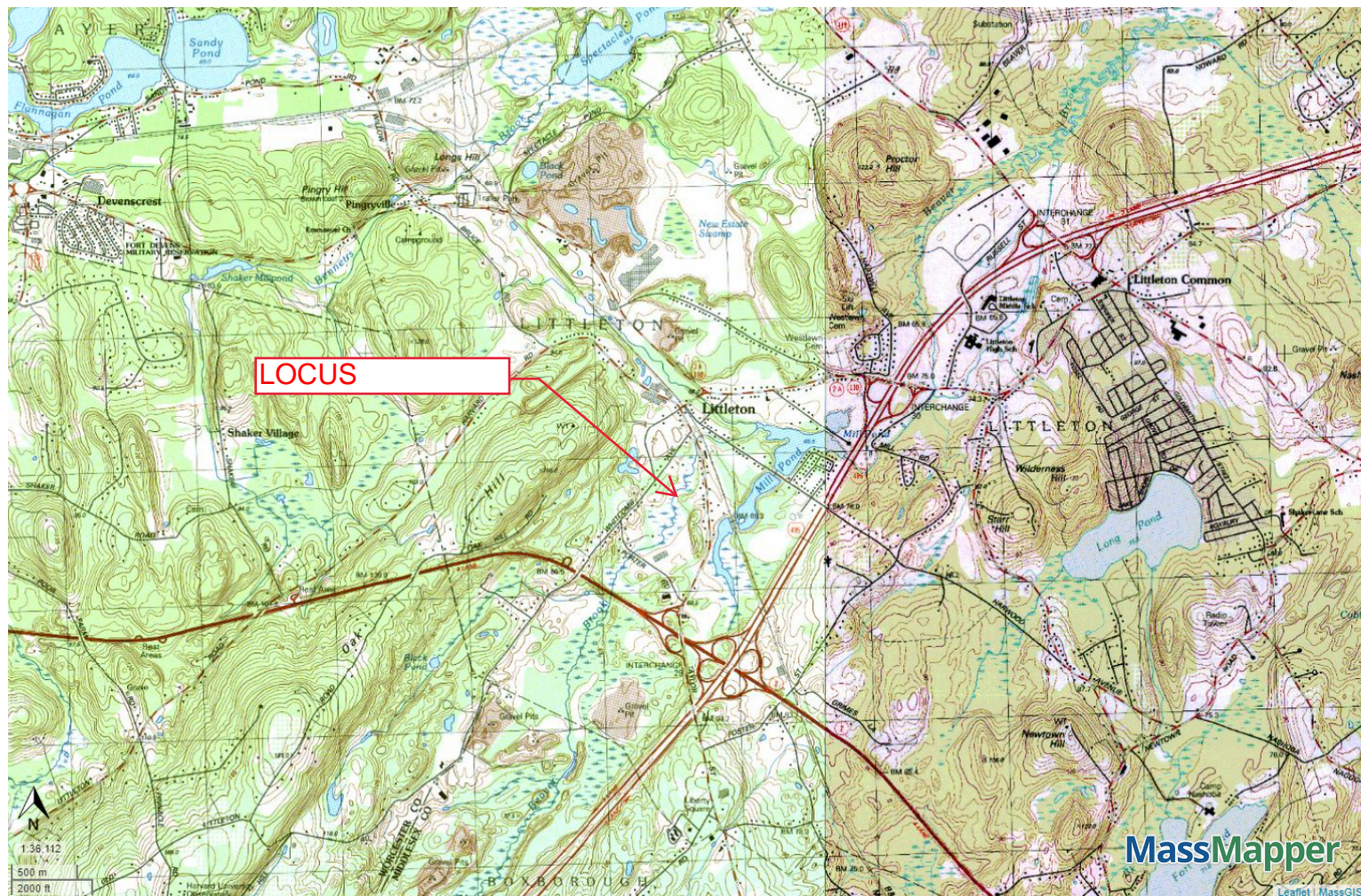

U.S.G.S. Locus Map

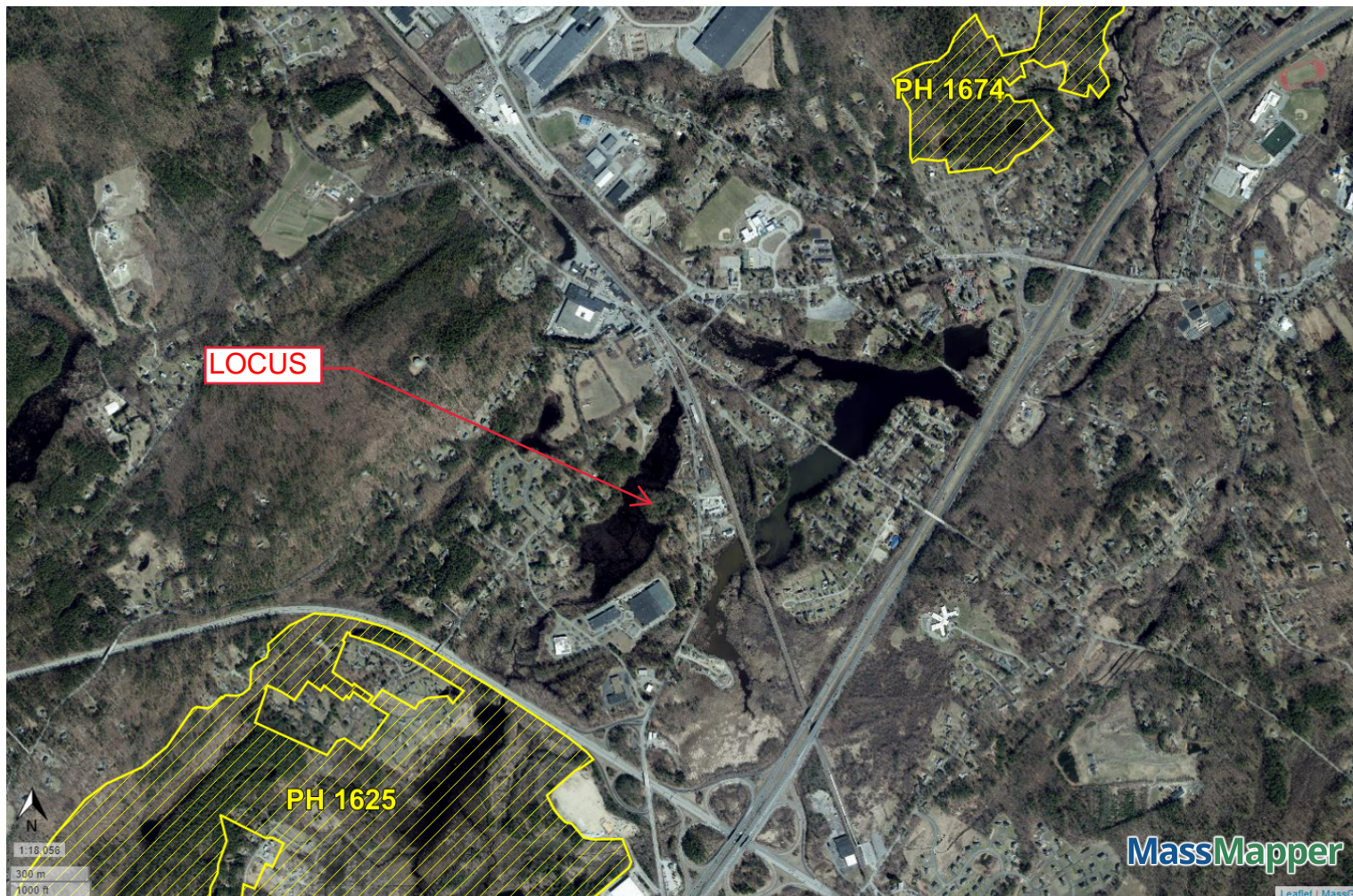
