Project Updates

Senior Center Building Update

The construction under Commodore Builders with the oversight of our Project Managers from Vertex continues as planned and on schedule. The concrete footings are complete, and backfilling is now taking place. Next up is installing utilities – below slab plumbing and piping, below slab electrical, installing the water main to the building, installing electrical duct bank to the building. Steel framing is planned to begin in June. Stay tuned for a beam signing ceremony and cookout in June to celebrate another milestone in the project!

36 King Street Update

The February 15, 2023, Special Town Meeting voted to purchase the former

Indian Hill Music School at 36 King Street in Littleton for \$3,500,000. The Town subsequently worked to develop a design of the approximately 21,500 square-foot building to accommodate the Parks, Recreation, and Community Education (PRCE) Department and the Littleton School Department Administration.

The May 7, 2024, Annual Town Meeting just approved Article 12 to fund the rehabilitation. The allocated \$2,981,047 is based on an actual bid from Classic Construction of Littleton. Objectives for the renovation include:

- Replacement of a 30+ year asphalt shingle roof (16,000 square feet)
- Repair exterior trim
- Repaint exterior trim and siding
- Minor fire suppression repairs
- Upgrade lighting to energy-efficient fixtures
- HVAC equipment maintenance and replacement where required
- Refinish interior wood floors
- Replace interior carpets

- Repaint interior walls, door frames and ceilings
- Install Town compatible security system
- Install Fire Department compliant equipment
- Upgrade technology to Town compliant system
- Interior space reconfiguration for programmatic needs
- Replace interior ADA/wayfinding signage
- Replace exterior building signage
- Moving needs for existing equipment & furniture

Classic Construction intends to mobilize in the May/June timeframe. The estimated eight-month renovation is scheduled for completion in late winter 2025. The renovated building will ultimately accommodate all PRCE, School Administration staff, and the after-school program, which are all currently located in Town Hall. Our thanks to Town Meeting for your continued support of this project.

New Health Department

In March of 2024, the approach in which Littleton receives health services underwent a significant transformation, transitioning from reliance on regional services provided by the Nashoba Associated Boards of Health to a localized health services model through a staffed department. In this pivotal shift, the Town and Board of Health made a strategic decision to appoint a Health Director to successfully establish and build a department. The Town welcomed Francis Dagle as Littleton's Health Director. The new Health Director assumes a crucial role in orchestrating the department's operations and shaping its

future trajectory. His responsibilities encompass not only the day-to-day management but also the conceptualization and realization of the department's evolving identity and vision for the future. Community members are encouraged to reach out to [Mr. Dagle](#) with any public health questions or concerns they may have.

School Committee Update

Greetings to the community from the Littleton School Committee! We hope that this article will shine a light on some important honors and achievements happening in our schools.

Littleton High School earned high national and metro-area rankings in the 2024 Best High Schools, which the U.S. News and World Report released on April 30. By earning a national ranking in the top 40%, Littleton High Schools achieved status as a U.S. News Best High School. LHS ranked #36 in MA and #834 nationally. This honor also speaks to the achievements of the school system as a whole as educators at Shaker Lane, Russell Street, and Littleton Middle School prepare students for success at the high school level.



In November, Littleton Middle School was recognized as part of the 2024 U.S. News and World Report Best Middle Schools. It was ranked 138 out of 1,040 middle schools in Massachusetts. The middle school was also recognized by the Department of Elementary and Secondary Education (DESE) as one of the 66 top performing schools in the state.



Some individual students received important awards that deserve public recognition. Seven high school students participated in the state Massachusetts Science and Engineering Fair (MSEF) on April 5 at Gillette Stadium. The team received three awards;

Finn Canning and Finley Pletcher received the award for Outstanding Environmental Science Project, Arohan Pathak and Siddarth Padamati were awarded the Ricoh Sustainable Development Award, and Anika Jacob received an award for excellence in design and implementation. We're also delighted to report that Harish Ganesh attended the 2024 DECA International Career Development Conference in Anaheim on April 29, and came away with third place in financial consulting. We're very proud of these students and hope they bring their passion with them into the future.



In addition to these accolades, we would like to draw attention to an exciting student initiative. Students at LMS and LHS are involved in the Playbook Initiative which is a partnership between Project 351 and the Boston Celtics. The program trained two high school students, Haaris Khan and Kierob Cherubino, to facilitate middle school students in discussions around diversity, equity, inclusion, and belonging. The powerful impact of this program was on display when a large group of students spoke about the initiative at a school committee meeting in January.

The Conservation Department

The Amphibian Crossing Brigade worked hard on rainy nights at the end of February and beginning of March helping about 500 frogs and salamanders cross busy streets so that they can get to the vernal pools to breed. About 20 people, some from as far away as Boston, came out to help. We were also able to collect data from the vernal pool at Browns' Woods and will be getting the area certified by the State.

That was followed by Garlic Mustard pull season. Garlic mustard is a non-native, invasive plant species that is easy to pull at the beginning of the season and, with at least a couple of years of follow up, can eventually be removed from the area it is invading. The Littleton Conservation Trust (LCT) led a garlic mustard pull day and there will be follow ups so stay tuned!

Parks and Rec also helped lead the charge to have a weekend event to remove invasives plants from the "Frog Pond" and give the folks in the Long Lake Neighborhood a hand with their ongoing efforts to control invasives in their neighborhood. If you are interested in learning more about invasive plant species, you can become a Weed Warrior. The next events are May 24th at the Smith property and June 15th at Browns' Woods.

Real Estate and Personal Property Tax Information



If you have not paid your FY24 Real Estate taxes in full by June 3, 2024, there will be a demand bill mailed. It will include a \$30 demand fee plus interest on the unpaid balance. The final quarterly payment was due on 5-1-24.

If you have not paid your Excise tax bills that were due on March 29, 2024, a demand bill will be mailed on May 20, 2024. This bill will have a \$10 fee plus interest.

The second RMV Excise tax billing was mailed on 5-8-24 for vehicles that were registered in the months of January 2024– March 2024. Please contact the Assessor's office at 978-540-2410 if you long owner own your vehicle. The RMV does not let us know!

Quarter 1 tax bills will be mailed by June 30, 2024. Bills are due on August 1, 2024.

You have numerous options for payment of Real Estate, Personal Property and Excise tax bills.

1. ONLINE PAYMENTS—We encourage you to pay your bill online using the ONLINE PAYMENTS link on the town's website www.littletononma.org. Credit and debit cards have a convenience fee charged by the bank, but ACH is free to residents as the town pays this fee.

2. DROP OFF BOX—For added convenience there is a secure payment drop off box located outside the main entrance to town hall.

3. MAIL—You may mail your check to the Town of Littleton, Tax Collector, PO Box 1305, Littleton, MA 01460 or to the town's lockbox bank at PO Box 882, Reading, MA 01867

4. IN PERSON HOURS—You may make payments in-person during office hours:

Mon 8am to 6pm

Tues thru Thurs 8am to 4:30pm

Friday 8am to 12:30pm

5. ELECTRONIC BANK CHECKS—If using electronic bank checks please put the bill number on the memo line.

Littleton, MA 01460.

DO NOT use the lockbox address in Reading. This could delay your payment from being posted to your account. Interest begins to accrue the day after the payment is due.



If you haven't joined us yet for programs, special events, or facilities the Littleton Parks, Recreation & Community Education (PRCE) department's mission is to provide year-round high quality indoor and outdoor recreation and enrichment activities for children and adults in Littleton and the surrounding communities. Our goal is to provide cultural, social, and athletic programs in well maintained parks and facilities. To date we are honored to have served 50% of Littleton households and would love to encourage you to check us out if you haven't yet.

I also wanted to give an update on some of the projects that we are working on around town. At Long lake this summer we are going to install a permanent ADA/AAB walking path at Long Lake Beach; it will run from the corner of Beach Drive and Lake Shore Drive across the beach and connect with the parking lot. This path will permanently replace one section of the season ADA access mat. At May Town meeting we were awarded Community Preservation Act funds to completed resurfacing of the basketball courts at 300 King and to purchase another section of dock at Long Lake that would allow better access to the swimming area and allow us to create a separate fishing dock off of conservation land on Lake Shore Drive.



Third Thursdays have also kicked off for the summer. They run the third Thursday of May, June, July, and August. This event is an open-air marketplace is made up of farmers, local businesses, crafters, artisans and organizations, highlighting the community while creating family fun! Third Thursday takes place at Faye Park located at 20 Foster Street, Littleton MA, 01460. The events will run from 5:00p - 7:00pm. Free Parking & Free Admission.

LPD was awarded the FBI-LEEDA Trilogy Award for the Department.

This was awarded to all law enforcement departments that trains their entire command staff in Supervisory, Command and Executive level trainings with the FBI-LEEDA program.

Only 9 other departments in Massachusetts have achieved this status.

Chief Matthew Pinard reports that the Littleton Police Department will begin deploying body-worn cameras on all officers starting on Monday, May 20.

Funding for the body-worn cameras comes from the Healy-Driscoll Administration's \$3.6 million Fiscal Year 2024 Body-Worn Cameras Grant Program, which awarded Littleton Police \$150,047 to launch its program.

All 23 members of the department, including the Chief and Deputy Chief, have been outfitted with body-worn cameras, which are embedded in their uniform to prevent them from detaching, and have received training from Motorola on how the devices operate and function.

Officers are now required by department policy to wear a body-worn camera at all times during their shift. Policy dictates that they activate the camera during all interactions with the public that are a result of a call for service, or any investigative or enforcement activity. Officers will keep in consideration the expectation of privacy when activating the body-worn camera in certain areas, such as private residences or hospitals.

Prior to the launch of the program, the department completed research into policy and best practices, vetted vendors, negotiated with the police union, worked with the selected vendor to tailor the system for the department's needs, and developed formal policies for camera use and data storage.

"I want to thank the administration for the generous grant funding which enabled us to launch this program without burdening the taxpayers of Littleton," said Chief Pinard. "We are excited to roll out this new program and to increase our level of transparency as we serve the Littleton community."

The month of May being Mental Health Awareness month allows for the opportunity to speak to the Littleton Police Department's steadfast commitment to addressing mental health issues as we respond to calls for service within our community. Increasingly today, law enforcement response to individuals in crisis has become a more common occurrence and concern amongst citizens. By employing specific strategies and programs surrounding the mental wellbeing of individuals, we can affect positive outcomes in our daily encounters within the community.

The Littleton Police Department is partnered with The Northwest Middlesex Community Outreach Initiative Network (COIN). COIN is a ten-town collaborative seeking to assist those suffering from substance use and/or mental health disorders by connecting them to services and treatment options available to them. As part of this partnership, Littleton benefits from a Police Clinician Co-Response program.

Susan Lemere is a Licensed Independent Clinical Social Worker employed by COIN and assigned to the communities of Littleton, Westford, Boxboro, and Ayer. The program aims to provide immediate on-scene assessment, intervention, and referral to appropriate services, with the goal of de-escalating situations, reducing the use of force, and diverting individuals from the criminal justice system to mental health services.

During the week Susan divides her time amongst the departments, riding alongside officers, readily available to assist each department as her expertise is needed. Her relationships with the police agencies and the officers working by her side, along with the intimate knowledge and experiences gained working with the officers on scene during calls, is an invaluable resource and benefit to the departments as well as the individuals in need of services.

COIN provides follow-on care by providing post-response services as well. Their Community Counselors can establish continued care by creating relationships with individuals ensuring ongoing support and treatment is available to them. Recycling In Littleton

Effective April 1, 2000 Massachusetts State Regulation 310 CMR 19.017 prohibits the disposal, or transfer or disposal of the following materials:

Asphalt pavement, brick and concrete
Cathode ray tubes
Clean gypsum wallboard
Ferrous and non-ferrous metals
Glass and metal containers
Lead acid batteries
Leaves and yard waste
Mattresses (effective November 1, 2022)
Recyclable paper, cardboard and paperboard
Single-resin narrow-necked plastic containers
Textiles (effective November 1, 2022)
Treated and untreated wood and wood waste (banned from landfills only)
White goods (large appliances)
Whole tires (banned from landfills only; shredded tires acceptable)



The following materials are **NOT** Acceptable in any container and **MUST** be recycled.

Glass (Bottles and Jars only)
Tin and Aluminum Cans
Plastics (# 1 and # 2 only)
Newspaper, cardboard and mixed paper
Yard Waste (Grass and Leaves)
Brush (Fee)
Auto and Household Batteries
Appliances (Fee)
Tires (16 inch maximum, Fee)
Used Motor Oil and Antifreeze
Scrap metal
Returnable Cans and Bottles (for non-profit groups)

Transfer Station - Adopted by the Select Board May 13, 2024—Effective Date July 1, 2024

Residents may purchase stickers at the **Transfer Station**

or online thru UniPay. Stickers are sold daily

until one half hour before the posted closing time.

Stickers are sold on an annual basis. When purchasing a Transfer Station Sticker, residents must bring their vehicle registration as well as proof of residency.

Note:

Stickers entitle users to dispose of routine household residential refuse.

Stickers must be affixed to the lower left hand portion of the windshield at the time of purchase.

Access to the Transfer Station can be denied if the sticker is not affixed.

Fees for Miscellaneous Items entitle users with stickers to dispose of non-routine items on a periodic basis. In certain circumstances the user may be asked to identify the source of the non-routine item in order to be permitted to dispose of the item.

A pickup with a “load” is understood to be substantially full. The Attendant’s judgment shall be final in this matter.

The Attendant shall have the option of temporarily restricting the use of the Transfer Station due to operational or space problems.

Users may purchase stickers or pay fees at the Transfer Station with checks or credit cards. No cash will be accepted at the Transfer Station for Security Purposes. The appropriate fees will be collected for those items set out in the Transfer Station Fee Schedule regardless of whether the item is left in the swap shop or is to be discarded.

These Transfer Station Sticker Fees are valid from July 1st to June 30th of the following year.



First Political Cartoon May 9, 1754



Join or Die
Library of Congress
Illustrated in the Pennsylvania Gazette, May 9, 1754

Join or Die, the first political cartoon published in an American newspaper, illustrates Benjamin Franklin's warning to the British colonies in America "join or die" and exhorting them to unite against the French and the Natives. It shows a segmented snake, "S.C., N.C., V., P., N.J., N.Y., [and] N.E."

This cartoon appeared in Ben Franklin's newspaper, the Pennsylvania Gazette on May 9, 1754 as part of an editorial by Franklin commenting on "the present disunited state of the British Colonies."

The woodcut drawing pictures a divided snake in eight pieces representing as many colonial governments. The drawing was based on the popular superstition that a snake that had been cut in two would come to life if the pieces were joined before sunset. The drawing immediately caught the public's fancy and was reproduced in other newspapers.
