Hi Maren, this is the Littleton Shade Tree Committee, writing in response to Mark Gallagher who came to the last committee meeting for clarification on town owned tree replacements for the project at 95 Taylor St. The STC proposes:

For any removed tree under 6" in Caliper, replace with one shade tree no smaller than 3-3.5" Caliper from the STC approved tree list.

For any removed tree 6" to 12" in Caliper, replace with 2 shade trees no smaller than 3-3.5" Caliper from the STC approved tree list.

Replacement trees shall be of a size and species approved by the Tree Warden, and shall be planted on public property, along rights of way or within easements as permitted by Mass. Gen. L. Ch. 87 Section 7, and determined by the Tree Warden.

If not installed by the owner/contractor/developer, payment for the replacement trees can be made to the Town. Retail costs of the replacement tree(s) will be doubled, to support the installation and maintenance costs for the Town of Littleton Highway Department.

I haven't heard back from Steve Whitten on this yet, but we hear that Planning is in a rush to get this done, so we wanted to send this along as quickly as possible. Let us know if you need anything else from us.
