Message From Your Select Board



We are delighted to share with you the latest news and updates with a recap of some of the key events and decisions made by the Select Board in the past month:



Topping Off Ceremony at Center on Shattuck Street:

The highlight of last month was the "topping off" ceremony for the Center on Shattuck Street, also known as the new senior center. On June 27, the final structural beam was placed, marking a significant milestone in the construction process. This event brings us closer to the completion of this essential community hub.

Select Board Updates:

- Approval was granted for Scout Mattias La-Croix's Eagle Scout project to install a self-serve little food pantry outside Elder Human Services. This initiative will provide much-needed support to those in need within our community.
- We celebrated the achievement of the Trilogy Award by the Littleton Police Department—recognizing their leadership training excellence and placing

them among a highly select group in Massachusetts and the nation.

- Revised Host Community Agreements were approved for Community Care Collective, MRM Industries, LLC, G7 Labs, and Sanctuary Medicals, aligning with updated state requirements and the Model HCA recently released by the Cannabis Control Commission.

- New member appointments were made to key committees like the Sustainability Committee, Conservation Commission, Council on Aging, and more. We extend our gratitude to those who have volunteered their time, and we encourage others to explore opportunities to contribute to our town's progress. Your participation and feedback are vital in shaping Littleton's future. Together, we can continue to build a thriving community for all. Nagog Hill Orchard Discussions:

The Select Board met on July 8 to continue discussion on the

future of the orchard. A primary focus is fact-gathering. The removal of the trees and stumps on the 48-acre property will cost ~\$10,000/acre. Tree removal is considered necessary because the trees are spreading disease and their presence makes it more difficult to find a new caretaker. Additionally, the SB received a professional estimate on the market value of the farmhouse and its unrestricted lot, estimated at \$500,000-\$600,000. The SB decided to move forward with another attempt to lease the orchard as-is while we work on long-term solutions. Plans include addressing tree removal and exploring the property's market value. Public forums hosted by a facilitator will be scheduled to gather community input on the orchard's future. Stay tuned for details on these important discussions.

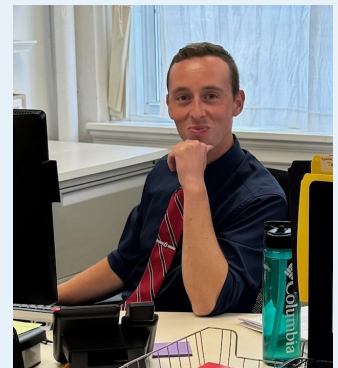

Radon can build up inside your house and cause lung cancer if you breathe it in over many years. Any home can have a radon problem, no matter the foundation type. Testing your home is the only way to know if radon is a problem.

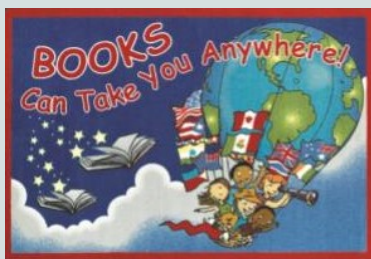

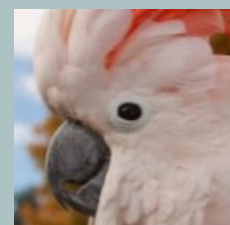

⇒ **When are the bills mailed to you? Four times a year.**

- ⇒ **Qtr 1** mailed by June 30 (**due 8-1**) Interest starts being charged 8-2
- ⇒ **Qtr 2** mailed by September 30 (**due 11-1**) Interest starts being charged 11-2
- ⇒ **Qtr 3** mailed by December 31 (**due Feb 1**) Interest starts being charged 2-2
- ⇒ **Qtr 4** mailed by March 31 (**due May 1**) Interest starts being charged 5-2
- ⇒ Per Mass General Law, bills are mailed to every homeowner in Littleton even if you escrow your taxes. Please contact us if you have **NOT** received a bill.
- ⇒ Please open the bills even if you escrow, as mortgage companies do make mistakes and can miss a payment. It is your responsibility to notify them if that happens. Especially if you switch mortgage companies

Excise Tax Bills

Calendar Year Jan 1 – Dec 31

The [Registry of Motor Vehicles](#) (RMV) identifies which municipality will collect the Excise Tax based on where the vehicle is garaged, as determined by the registration of your license plate. Only the person registered to that license plate can change the address of the registration with the Registry of Motor Vehicles.

- ⇒ **When are the bills mailed to you?** Motor Vehicle Excise Bills are released by March 1st, and apply to the full calendar year (Jan thru Dec). **It is your responsibility to notify us if you have not received a bill in the first week of March.**
- ⇒ Please pay your bills by the due date on the bill. RMV will mail demand bills with interest and fees if not paid on time!
- ⇒ Please contact the [assessor's office](#) at 978-540-2410 for any of the below circumstances. The RMV DOES NOT relay to us these circumstances. There is paperwork that needs to be provided and [abatement forms](#) to be filled out by you the owner of the vehicle.
- ⇒ If you buy a vehicle and register new plates during the year, you will receive an Excise Bill for the portion of the year which runs from the date of registration thru Dec 31. Keep an eye out for that bill. It is mailed at different times throughout the year. After that initial bill, future bills will be on the annual (12- month) billing cycle (mailed in March of every year).
- ⇒ If you transfer your plate from one vehicle to another vehicle, you will receive an Excise Bill for the new vehicle AND you should apply for an [abatement](#) on the first vehicle's Excise Tax.
- ⇒ If you trade in, sell, donate, or totaled your vehicle the **RMV DOES NOT** notify us when this takes place. You will continue to receive past -due bills if this is not done. These past- due bills will have additional fees and interest.
- ⇒ If you move out of state, please cancel your plate with the RMV ASAP, then contact the Assessor's Office. The Town of Littleton is **NOT** notified by the MA RMV nor the new state where you are moving to that you have registered the vehicle elsewhere. You will continue to receive a bill if this is not done. RMV will start charging fees and interest.
- ⇒ If you moved to another city or town in MA please pay the Town of Littleton. As long as you have changed your address with the RMV, in the following year you will be billed by that town.

We gathered together once again to celebrate another significant milestone reached in the construction of the Center on Shattuck Street, future Home to Elder and Human Services, Council on Aging, and Veterans Services- The Topping Off Ceremony. Last time we gathered together, we celebrated the groundbreaking together.

And just a few short weeks later, we gathered again for the Topping Off Ceremony which marks a pivotal moment in our journey—a moment where we can actually see the framework of our vision taking shape and becoming a reality.

What is a “Topping Off Ceremony?” It is the last steel beam placed is a major milestone in the evolution of a building project. The beam is adorned with a small evergreen tree and an American flag on opposite ends of the beam. It uniquely honors the accomplishments of the construction crew. The tree is the key symbol. In the steel trade, it signifies construction has reached the sky without loss of life or injury and it bodes well for the future inhabitants of the building.

This final beam being placed is a testament to the hard work and collaboration of so many individuals. I would like to extend my deepest appreciation to everyone involved in this project. To our Vertex project managers, Commodore Builders, our architects at LLB, our contractors, sub-contractors, and construction teams—your expertise and perseverance have been instrumental in reaching this milestone. I have received feedback that this has been the tidiest construction sites people have ever seen. A huge testament to the pride you take in your craft.

To our Select Board, our Legislators, PMBC, COA and Friends Boards, and community supporters—your decades of vision and unwavering support have been the foundation upon which this project was built. To our neighbors and community members—your patience, suggestions, feedback, and encouragement have been invaluable throughout this process. To Town Hall staff, thank you for bearing with us- I know construction is not quiet, and parking spots are at a premium.

As we look forward to the completion of the Center on Shattuck Street, let us also take a moment to reflect on the journey we have undertaken together, and remember those who have been instrumental to us being here, but are no longer with us. A reminder that this project represents decades of our collective effort, our shared visions, and our commitment to creating an age friendly and inclusive Littleton. The steel framework here will house lifelong learning, creativity, and connection. The open beams you see are symbolic to us in the way that the work we do within this building will extend to the entire community; our work does not stop at the four walls of a building.

Together, we have reached this incredible milestone, and together, we will see this project through to its successful completion. Here's to the future of the Center on Shattuck Street, and to the many possibilities it will bring to our community.

Naming of the building

After careful consideration, the Council on Aging Board voted to recommend the name "The Center on Shattuck Street: Home of Elder and Human Services, Council on Aging, and Veterans Services" for the new senior center building. On June 24th, the Select Board voted to accept the name "The Center on Shattuck Street" officially in accordance with Select Board Regulations and Policies' 'Policy on Naming Town Facilities'. We believe the name "The Center on Shattuck Street" is versatile and inclusive of all the services housed inside of the building: the senior center, the Elder and Human Services Department, and the Veterans Services Agent. Tax Relief for the Elderly and Disabled (T.R.E.A.D.)

Are you a Littleton senior resident or disabled resident who needs assistance with their property taxes? Massachusetts State Law Chapter 60, Section 3D, allows a fund to be created to collect donations and disburse them to low-income elderly property owners and qualifying disabled owners. Here in Littleton, we call it the T.R.E.A.D. program. The application period is open now through September 30th, 2024.

Applicants must meet the following criteria:

- Must own and occupy the property
- Must be 65 or older or have a state-recognized disability
- Must file an application disclosing exemptions and household income and expenses for all household members age 18 or older

Applications can be obtained from the Department of Elder and Human Services, 33 Shattuck Street, Littleton, or by coming to our office in Town Hall, Room 231. If you need assistance filling out an application please call Amy or Alicia at 978-540-2470.

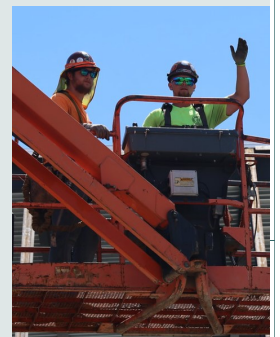

Transfer Station - Adopted by the Select Board May 13, 2024—Effective Date July 1, 2024

Residents may purchase stickers at the **Transfer Station**

or online thru UniPay. Stickers are sold daily until one half hour before the posted closing time.

Stickers are sold on an annual basis. When purchasing a Transfer Station Sticker, residents must bring their vehicle registration as well as proof of residency.

Note:

Stickers entitle users to dispose of routine household residential refuse.

Stickers must be affixed to the lower left hand portion of the windshield at the time of purchase.

Access to the Transfer Station can be denied if the sticker is not affixed.

Fees for Miscellaneous Items entitle users with stickers to dispose of non-routine items on a periodic basis. In certain circumstances the user may be asked to identify the source of the non-routine item in order to be permitted to dispose of the item.

A pickup with a “load” is understood to be substantially full. The Attendant’s judgment shall be final in this matter.

The Attendant shall have the option of temporarily restricting the use of the Transfer Station due to operational or space problems.

Users may purchase stickers or pay fees at the Transfer Station with checks or credit cards. No cash will be accepted at the Transfer Station for Security Purposes.

The appropriate fees will be collected for those items set out in the Transfer Station Fee Schedule regardless of whether the item is left in the swap shop or is to be discarded.

These Transfer Station Sticker Fees are valid from July 1st to June 30th of the following year.

Affordable Housing Trust

On June 25th the [Affordable Housing Trust](#) (AHT) met jointly with the [Community Preservation Committee](#) (CPC) to finalize a Grant Agreement. The agreement formalizes the process for CPC funding that is used by the AHT. Any such funding will be spent on a specific project. These funds will be utilized solely for CPA eligible activities specifically to create, acquire, preserve, and support community housing for the benefit of low and moderate income individuals and families in Littleton.

The AHT also held a regular meeting on June 25th to address two of the major components of the 5-Year Action Plan: the construction of affordable housing on Tahattawan Road, and potential uses of the Durkee Farm property on Foster St.

Habitat for Humanity was the only respondent to the Request for Proposal (RFP) for the construction and sale of two units of affordable housing on the Tahattawan Road property. The AHT discussed that response and will pursue further information and negotiations.

The AHT voted to approve up to \$3300 for surveying the Durkee Property: a step needed to determine a septic site and conservation set backs. Surveying and marking the property lines was completed on July 2nd.

The Trustees also discussed the recent King Street Special Permit Decision for 550 King St.. In that document it is stated that the 40 units of “deeply affordable” (30-60% of Area Median Income) housing, designated for seniors only, will be completed in Phase 3 of the project. The timeline shows that 2027-2029 is the anticipated framework for Phase 3.

The AHT will be sponsoring a presentation about the ***Economics and Realities of Housing for Seniors in Littleton on Wednesday, August 21st at 2PM in the Sturtz Room of the Reuben Hoar Library***. The presentation will include aging in place, downsizing, and renting as well as the financial thresholds for affordable housing qualifications. Please register to attend and answer the questions that will help us focus the information to be provided.

Member Mark Rambacher and Town Planner Maren Toohill have submitted an application for a ***Community One Stop for Growth*** grant which would provide eligible homeowners with a mini grant for critical repairs, helping them to stay in their homes as they age. The Town will find out if it is successful in late October or early November.

The Affordable Housing Trust typically meets on the third Tuesday of every month, and all meetings are open to the public. Specific meeting schedules may be found on the town website. The meetings are recorded and available on LCTV's On Demand.

Historical Commission

Barn Roof Raising - On June 17, 2024, an unusual event occurred in Littleton at 12 Robinson Road. The large rectangular roof that had been sitting in the front yard for a few weeks was carefully secured by strappings to protect this historic structure, raised by a huge crane high into the air, and precisely placed on top of the barn at the site. Prior to this, the roof and gables were lifted by a crane and removed, a foundation was installed, and the walls rebuilt, including reinstallation of most of the major original structural king posts. This was part of a larger collaborative effort by the Historical Commission, Building Department, and property owner Joe Cataldo to preserve both the historic house (built mid-1700s) and barn (built late 1800s) at the site. The Town of Littleton purchased the property with CPC funds in 2018 and sold it to Joe Cataldo in 2021. The Historical Commission is tasked with ensuring that the two historic structures are preserved in perpetuity. Nagog Hill Orchard Working Group

When John and Eunice Morrison purchased the property known today as Nagog Hill Orchard, they worked hard to convert the land solely to fruit trees and some vegetables. This commercially operated family farm business brought them income, provided local fresh food, and employment for two year-round staff and 3–9 seasonal staff per year. After John's passing, Eunice, with no children or other family members interested in continuing the farm, she faced decisions about the property's future. Despite lucrative offers from developers, which today would exceed \$11.5 million adjusted for inflation, Eunice chose land preservation.

To safeguard her vision, Eunice partnered with the town of Littleton and secured assurances that the property would remain dedicated to agricultural use and open space. This commitment was crucial in ensuring that Nagog Hill Orchard would not be converted for other purposes, including town departmental use, schools, commercial endeavors (except for farm stands), or residential development. It was a requirement that the Nagog Hill property be transferred to the Town of Littleton and the Town of Concord Water System, under the condition that the land remain designated as “Farm or Conservation Land”. This agreement was also designed to safeguard our water supply at the Nagog Pond Reservoir. Eunice and the town utilized two state-run programs to achieve her vision.

Eunice leveraged two state programs; the Agricultural Preservation Restriction Program (APR) through the Massachusetts Department of Agriculture (MDAR) and the Conservation Restriction Program (CRP) through the Division of Conservation Services. These programs enabled her to protect approximately 124 acres of land. About 76 acres were designated under CRP and self-help initiatives, while approximately 48 acres were enrolled in the APR program. The APR designation permanently restricts land use to commercial agricultural purposes, thereby ensuring its long-term preservation for farming. The Agricultural Preservation Restriction Program secured Eunice's estate planning, and allowed her to become one of our town's true philanthropists. The APR program at Nagog Hill enabled MDAR to add additional acres to the program to further the objective of revitalizing the agricultural industry by purchasing the deed restriction, protecting soils, and increasing land affordability for farmers across the Commonwealth.

The APR program has a significant positive impact on farmers, the agricultural industry, state and local economies, and consumers. It strengthens our state's \$550 million agricultural industry, maintains farms in active commercial use, and supports farmers, fostering a robust and sustainable agricultural economy. Additionally, it enables both new and experienced farmers to acquire affordable land, it stabilizes farmland values, and ensures long-term access to farmland. Just like homeownership, owning land is an asset class that historically outperforms the S&P 500. Land ownership allows for leveraging and serves as collateral, which is a crucial factor for farmers who prioritize owning land over renting. Land ownership, like homeownership, secures wealth and intergenerational inheritance and financial security. Homeowners can leverage the value of their assets to take out a car loan or pay for college tuition. Farmers also want to be able to leverage their assets to pay for equipment or send their children to college. Given the very thin margins in farming, landownership is often what separates farms that succeed and those that don't.

According to the Massachusetts 2022 USDA reports, there are 13,284 producers, 5,337 producers are aged 65 years and older, 4,070 are new and beginning farmers. 12,861 producers identify as White, 95% are family farmers, with only 86% having internet access. Farmland values rank the third highest in the country, and median house prices rank 5th and are rising. The APR program offers a crucial opportunity for the 4,070 new and beginning farmers who seek affordable farmland ownership as older farmers seek to retire. Forty percent of American farmland is owned by people age 65 and older, while the number of beginning farmers and ranchers keeps falling. Farming and ranching have high barriers to entry, coupled with low financial returns. Many people who want to farm simply cannot afford to do so.

Nagog Hill Orchard Working Group—continued

Nagog Hill Orchard stands as a beacon for the next generation of farmers, symbolizing an opportunity to farm with the security of landownership. Nagog Hill, under the APR program, strengthens our farm community, ensuring productive agricultural use and increases regional food security for all eaters. Amid challenges like pandemics and climate change, it serves as an insurance policy, offering fresh, local food when supply chains fail. Nagog Hill is not intended to be minimally farmed or have minimal farm sales, nor should the APR be treated under the false pretense of conservation to meet another aim. It's crucial that the objectives and goals of Eunice and the APR are met.

Eunice made a clear choice back in 1999 to not break up the property. She understood that a successful working farm required a house, barn, and land. The vote in 1999 was a promise to Eunice and the Concord Water Department that the town would look after and care for the land, house, barn, and protect the water supply at the base of Nagog Hill. The Orchard Working Group has tapped resources and lobbied both MDAR and the Littleton Historical Commission to try to further safeguard the property.

Despite three and a half years of expertise, research, efforts, and direction from the Nagog Orchard Working Group, challenges have arisen. Discussions about potentially dividing the house from the property for non-agricultural uses to generate immediate cash for short-term gain poses a significant threat. The “No” vote at Spring Town Meeting, did not save the orchard, it put it at more risk. The orchard continues to decline and the lawyers, real estate agents and developers are gathering.

The Nagog Orchard Working Group has strongly advocated for maintaining control over both the house and barn. Selling the house would contradict the long-term APR goals and Eunice set out to achieve. It diminishes the already very limited pool of applicants before a Request for Proposal is even made public. The Orchard Working Group stressed that only a farmer-owner can effectively manage the entire property in alignment with APR objectives, ensuring that Nagog Hill Orchard remains a thriving agricultural resource. Looking outward, there are new goals, priorities, and recommendations laid out in the MDAR Massachusetts Farmland Action Plan 2023-2050. This new comprehensive plan aims to strengthen the APR program and expand its impact across the state, and our recommendations align with new state policy.

Today, a potential deviation, indecision and further delays from the Working Group's recommendations has been marked by further decay of buildings, land and has now created the very real possibility for the splintering of the property for non-agricultural use. Eunice Morrison gave a gift to all Littleton residents, and it's time to fulfill the promise to honor the Morrison family legacy.
