





In order request a waiver, the following provides a guidance for required information (attach additional text, plans, photos or graphics if needed):

Project purpose and need: Approval to remove 9 trees.

What specific action(s) is the Waiver being asked for?

Given the issues and fear with falling branches, excess moisture, and decay, removing these trees near the property is crucial. This will allow more sunlight, helping to dry out areas that remain damp, reducing rot, mold growth, and pest issues. Once the surrounding environment is better managed, we will have the opportunity of replacing roof, windows, siding, and deck without having to worry about the current issues with the trees.
