### Message From Your Select Board

One consistent theme we hear from residents, town employees, officials and volunteers is the need for Littleton's government to keep pace with the evolving needs of the Town. Our population continues to grow, and major public and private projects are underway with more on the immediate horizon. It's been many years since the Town conducted a comprehensive review of our government structure, and a recent, limited report from the state's Division of Local Services identified several areas of potential improvement. The Select Board will therefore appoint a Charter Commission in January to conduct a comprehensive review of our current structure and identify recommendations for improvements. The Commission will be made up of 7-9 members at large. We encourage anyone with an interest in the subject and a desire to give back to the community to submit an application. The application will be posted on the town website, and we plan to make appointments in mid-January. Please keep an eye on the website for details.

Other items of note:

- We hope to see you at the Littleton Police Department on December 14 for LPD's annual Toys for Tots Drive from 10am-12pm.
- Special Town Meeting was held October 29. A huge thank you to the Town Clerk's office and LCTV for running yet another smooth event. Results are available here: <https://www.littletonma.org/CivicAlerts.aspx?AID=379>
- Annual Town Meeting will be held May 6, 2025. Please mark your calendars!
- Negotiations are progressing to lease the Nagog Hill Orchard with a goal to have an agreement in principle by the end of this year. Stay tuned for details on a public meeting with the potential lessee, Bransfield Tree Company. Safety repairs at the orchard are near completion.
- The SB will discuss lifting the truck exclusion on Taylor Street. Please refer to our posted [agendas](#) in December for details on when this discussion and vote will take place.
- Budget season is well underway. We are fortunate that in recent years – unlike many other towns in our area – Littleton has been able to meet all its day-to-day operational needs within the levy. Our goal is to continue to keep the operations budget within the levy, despite the pressures of inflation and capital projects already underway.

## Assessor's Department



Following State Statutes and Department of Revenue regulations FY25 values have been certified by the State on 10/29/2024. Fiscal Year 2025 values are based on calendar year 2023 Sales. The entire town is adjusted annually according to market data. Highlights include:

- Overall town valuation increased 4.7%
- Average Single-Family home increased 3.39%
- Average Single-Family home value is \$694,868.00
- Residential Valuation increased 3.6%
- Commercial/Industrial increased 6.19%
- Personal Property increased 2.85%

The Town of Littleton has a split tax rate. This allows a portion of the Tax burden to be shifted from Residential Properties to Commercial/Industrial/Personal Properties. The residential factor is voted at the annual Tax Classification Hearing by the Selectboard.

The new FY25 tax rates are Residential 14.86 and C/I/P 22.94.

Valuations are available online by clicking the link below and by stopping by the Assessor's office in Town Hall. The Assessor's will be available to discuss your new valuations but please keep in mind that abatement season runs from January 1, 2025 thru February 1, 2025.

Standard and Poor's has affirmed the Town of Littleton's bond rating of AAA, its highest rating. S&P defines its AAA rating as "Extremely strong capacity to meet financial commitments. Highest Rating." The rating reflects S&P's assessment of the following factors for the town:

Very strong economy - "Very high wealth and income metrics with ongoing tax base growth"

Very strong management, "Well-embedded financial management policies and practices, with a focus on long-term sustainability and a strong institutional framework score"

Strong budgetary performance - "... we expect the Town will maintain its strong performance as well as strong reserves, despite rising fixed costs in the medium term ...."

Very strong budgetary flexibility - "Management has demonstrated its willingness to adjust budgetary assumptions to ensure balanced financial results at year-end"

Very strong liquidity - "We have assessed the town's market risk as low, due to Littleton's strong market access, information availability, and takeout authorization"

Very strong debt and contingent liability profile - "Potentially rising fixed costs, but with a clear commitment to addressing unfunded retirement liabilities ..."

# Littleton Common Sewer Project Update



## Update on the Littleton Common Sewer Project

The Littleton Common Sewer Project is moving forward to improve wastewater infrastructure in the area. This effort supports local growth, protects the environment, and enhances the community's quality of life. The project involves two major parts:

- Building a new Water Resource Recovery Facility (WRRF): A modern, 1,400-square-foot plant is being built at 242 King Street.
- Expanding the Sewer System: This includes installing about 10,000 feet of new sewer pipes, constructing a new underground sewer pump station near Littleton High School, and upgrading an existing pump station at Russell Street Middle School.

Construction began in June 2023 after bids were awarded. Methuen Construction is handling the WRRF project for \$19.99 million, and Revoli Construction is managing the sewer expansion for \$19.39 million.

## Where Things Stand Now

The project is actively under construction. Crews are focusing on installing sewer lines and other infrastructure, mainly around King Street, to serve nearby homes and businesses.

- Sewer Line Work: Most of the sewer and water main installations are nearly done, with about 600 feet left to complete near the Westford town line.
- Working Hours: Crews are working day and night. To minimize traffic disruptions, sewer pipe installations on King Street are happening between 8 p.m. and 4 a.m., while temporary trench paving is scheduled during the day between 9 a.m. and 3 p.m.
- WRRF Progress: Significant progress is being made on the treatment plant. The equalization tank has been installed, site preparation continues, and work on the steel building has started. Once the building is sealed against the weather, the next step will be installing key treatment systems, with the goal of having the plant ready by early next summer.

## Why This Matters

When finished, the project will boost economic growth and protect the environment by reducing dependence on septic systems. The upgraded sewer system will support future development and ensure better waste management for the town.



# Project Updates



## The Center on Shattuck Street — October 2024 Update



During the month of October, Commodore made significant progress on the roof, and continued drywall and MEP installation throughout the building interior. Masonry work was completed around the building exterior, and site work progressed with the installation of binder course asphalt, bollards, and curbing. It is anticipated that

concrete will be poured for sidewalks and pads by mid-November.


Window installation, completed the previous month, underwent testing within a section of completed assembly on 10/30/24, and passed without issue. Commodore received AHJ review of the roughed-in Mechanical, Electrical, and Plumbing work, which was approved, allowing Commodore/Charles Services to make significant progress in-stalling, taping, and mudding drywall. The interior staircase for the building, fabricated off-site last month, was delivered and installed, and the concrete pan pours were placed within the steel stair pan to make the stairs usable during construction. The HVAC, Plumbing, and Electrical subcontractors continued rough-ins and wiring at both the upper and lower floors. In coordination with LELWD and the plumbing engineer, the Water Meter was delivered to the site, but unfortunately was the incorrect size and new flanged fittings needed to be ordered to accommodate the correct 2" size (which Commodore has on site, awaiting installation in November). The Electrical subcontractor is in-progress with installing secondary electrical feeds to the building.

On the administrative side, FF&E is awaiting final paperwork to present to PMBC at their next meeting on 11/13/24. This is on-budget and although the final number is known, the documentation is needed to back up the Purchase Order that will be issued by the Town. AV and Technology items are in final coordination with the Town / COA and expect to be completed shortly.

# Project Updates



## 36 King Street—October 2024 Update



During the month of October, Classic Construction completed exterior work on the building, including sheathing repairs, prep work, skylights, and Painting. Classic's goal was to complete all exterior work before Winter, which has been achieved. Following the successful installation of the skylights/SolaTubes, roofing work was completed by their subcontractor, Cape Cod Builders. Classic's carpenters continued framing new interior walls and Lower Level cubbies/shelves in

accordance with the architectural plans and ASI revisions, including framing and concrete leveling work at the Game Room. The structural columns at the lower level were installed by Brideau Sheet metal in coordination with Classic, who completed the installation by grouting the bases in place. Plumbing, HVAC, and Electrical work are ongoing throughout the building. Electrical is performing rough-in work throughout the building, while awaiting clarifications related to CPR-014R1 revisions by the design team and sketches describing the power requirements for the new HVAC units. HVAC is preparing to install the new replacement Magic Pak units at the attic, with a crane pick targeting mid-November. The Plumber performed modifications to support the first floor restroom and future second-floor kitchenette. Finally, Xcel Fire Protection performed diagnostic and repair work on the sprinkler system to correct leaks that had been leading to frequent compressor cycling. At the end of October, this intervention appears to have addressed the issue.

Classic's administrative efforts are ongoing through the Submittal, RFI, and PCO processes to document their intended material purchases/installation as well as questions for the design team based on in-field conditions. Classic and their subcontractors are current with Certified Payroll documentation as of the conclusion of this reporting period.


LLB continues to work with both Vertex and Classic to formally document any changes based on what is/has been uncovered, and is reviewing Submittals and RFI's that are generated in this process. Town Facilities was able to work with the School Department to replace the exterior/parking lot lighting after diagnosing the issue, and has confirmed that the lights are now operational. The Town also authorized additional investigative work to uncover and diagnose the Septic System where the pipe disappears underground when exiting the building; Classic plans to perform this work in early to mid-November. The building's elevator passed reinspection on 10/2/24, following completion of code upgrades and service last month.

As of the close of this October reporting period, the project is reporting schedule slippage, as Change Order work that is being coordinated between the design team and Classic is beginning to impact the Critical Path (these are primarily Owner-directed scope changes). With allowances for time associated with Change Order work, the project is tracking approximately 2 months behind the original Substantial Completion date. Vertex will continue to monitor schedule status as updates become available.



### Littleton Police Awarded \$19,863 in State Municipal Road Safety Grant Program

LITTLETON — Chief Matthew Pinard is pleased to share that the Littleton Police Department was awarded a \$19,863.50 grant through the state's Municipal Road Safety Grant Program.

Littleton Police will be using the funding to conduct directed traffic enforcement over the next few months. This will include several campaigns of enforcement, such as pedestrian and crosswalk safety, distracted driving, speeding, and other non-enforcement components including community education.


The grant is part of \$12.4 million in federal grant funding awarded by the Healey-Driscoll Administration to 191 municipal and state agencies for road safety improvement programs. The grants are administered through the Executive Office of Public Safety and Security's Office of Grants & Research.

"I would like to thank the Healey-Driscoll Administration for awarding us this funding which will help us continue to make Littleton roads safe for all," said Chief Pinard. "This funding will allow us to expand our traffic safety programs and mitigate unsafe driving practices by all."

# Fire Dept



As the winter months approach, the comfort of warm fireplaces, space heaters, and holiday decorations becomes a cherished part of our lives. However, these seasonal joys also bring an increased risk of fire hazards in our homes and workplaces. To keep you and your loved ones safe this winter, we would like to share some essential fire safety tips:

## Heating Equipment

- Keep a safe distance of at least three feet between heating equipment and flammable materials like curtains, furniture, or bedding.
- Never leave portable heaters unattended, and always turn them off when leaving a room or going to bed.

## Fireplaces and Chimneys

- Have chimneys inspected and cleaned annually to prevent creosote buildup, a leading cause of chimney fires.
- Use a fireplace screen to contain sparks and embers.
- Dispose of cooled ashes in a metal container, stored far from your home.



## Holiday Decorations

- If you use candles, place them in sturdy holders and away from flammable objects. Extinguish them before leaving the room.
- Use only lights labeled for indoor or outdoor use and check for frayed wires or broken bulbs before decorating.
- Water live Christmas trees daily to prevent them from drying out and becoming a fire hazard.

## Smoke Alarms and Fire Extinguishers

- Test smoke alarms monthly and replace batteries as needed. Ensure alarms are installed on every level of your home.
- Keep a fire extinguisher accessible and know how to use it.

## Emergency Planning

- Create and practice a fire escape plan with your family, including two ways out of every room.
- Ensure exits and escape routes remain clear of snow or ice.



### Planning Board Project Update

#### **Northern Bank - Great Road / Robinson Road**

The Planning Board is excited to recognize the construction for Northern Bank's comprehensive redevelopment of 5 parcels on Great Road and Robinson Road which began in November. This project was the first accepted application under Littleton's "New" (2020) Village Common Form-Based Code. For more information on Form-Based Code, please visit: <https://ma-littleton.civicplus.com/747/Village-Common-Form-Based-Code>

This new development will serve as a new "gateway" into Littleton and the Planning Board is happy to see the Littleton Common Revitalization Road Map come to life. This location will be evolving from several previously underutilized properties into a comprehensive "placemaking" destination. This project will bring unique and vibrant local businesses that offer a variety of services while preserving Littleton's New England community character.

The Rezoning of 25 Robinson Road from Residential to Village Common District at the October 25, 2021, Fall Town Meeting allowed this project to become viable. The Planning Board appreciates the Littleton residents and Select Board for supporting this effort. A special thank-you to the Robinson Road residents and to Northern Bank for responding to the concerns of the residents in the final design of the development.

The implementation of Littleton's new Town sewer allows significant redevelopment to take place and achieve Littleton's Planning goals. Previously, the lack of a municipal sewer system prevented such development from coming to fruition. The Construction team for Northern Bank expects this project to be on time to tie in with Littleton's new sewer system.

Northern Bank has submitted a permit application for the new foundation for the construction of Northern Bank & Trust Branch and is under review by Littleton's Building Commissioner. The Construction Supervisor has informed the Town that the full building permit application will be coming in shortly for the first building, which will be for the Bank on the corner of the site.



## School Committee

Greetings from the Littleton School Committee! We have lots of news to share through the month of November.

We are continuing our outreach to the community to become part of the discussion about a new Shaker Lane School, designed to accommodate our current and future programming needs. There were two site visits in November, where community members had the opportunity to tour the school and witness the heroic efforts of leaders and teachers to meet the needs of current students in a very confined space. These educators have shown their commitment to Littleton children, despite very challenging constraints posed by the current building. The town has a unique opportunity through the Massachusetts School Building Authority (MSBA) to have a significant portion of future building costs reimbursed by the state. As plans move forward, we welcome community input. Our next virtual meeting with the community will be held on December 18 at 7:00. Littleton Public Schools is excited to introduce SchoolStatus, a new platform designed to streamline communication across our district. With SchoolStatus, parents can easily access important school information, updates, and connect with the school community. They can choose if they want to receive messages via text, email, voice call, or the SchoolNow mobile app. The goal is to ensure that families never miss a school event, deadline, or important announcement. Families will receive an email with instructions on how to enroll.



On November 5, Littleton Public Schools collaborated with Ayer-Shirley and Harvard Public Schools on a Cross-District Professional Development Day for teachers. Teachers shared their expertise on a wide variety of topics in a workshop format. Altogether there were more than 50 workshops offered, so that all teachers had opportunities for professional growth on topics most relevant to their work. It was a fantastic community builder as well! Many thanks to Director of Teaching and Learning Beth Steele for her commitment and dedication in organizing this event for our teachers.

Cultural events are happening all across the district! On November 6 the Shaker Lane and Russell Street Schools collaborated on the second annual Cultural Fair that was enthusiastically received by families. Fourteen families shared their culture with attendees, ranging from visual representations, games and activities, foods, and other creative artifacts. ### Affordable Housing in Littleton

#### What is **Affordable Housing** in Littleton?

##### Defining Private Affordable Housing

**Housing is considered “affordable” when the household spends no more than 30% of their gross income on housing costs, which include rent or mortgage, insurance, and utilities.**



Some housing units are created specifically for households with low to moderate incomes and rent or sell for less than market-rate housing. These units are referred to as “affordable,” “subsidized,” or “income-restricted” housing.

##### Definitions of Income Limits

A low- to moderate-income (LMI) household is one with a gross annual income at or below 80% of the area median income (AMI).

Common definitions of income levels are:



- Extremely Low-Income: households with incomes at or below 30% AMI
- Very Low-Income: households with incomes between 30% and 50% AMI
- Low Income: households with incomes between 50% and 80% AMI
- Moderate/Middle Income: households with incomes between 80% and 120% AMI

##### Income Eligibility

Income eligibility for affordable housing is set at a percentage of the area median income (i.e. 30%, 50%, 60%, 80% AMI). Income limits are dependent on the number of persons in a household and may vary depending on the specific affordable housing program administering the project or subsidy.

As of April 1, 2024, the **Area Median Income (100% AMI) in Littleton for a family of 4 is \$148,900.**

Example of how to read this table:



- A new affordable housing development has just been built. A number of the units will be set aside for those households whose incomes are at or below 60% of the Area Median Income. Therefore, the gross annual income for a family of three must not exceed \$88,140 for the family to be eligible to live in the 60% AMI units.

### Maximum Rent

**Rents are not based on individual resident's income. The advertised rent is the rent a tenant will be expected to pay.**

The table below details the maximum rents for units set at different income levels for affordable, rental housing projects.

Example of how to read this table:



- The affordable housing development will include 50% AMI units. The monthly rent for a 3-bedroom 50% AMI unit (including the cost of utilities) must not exceed \$2,040.

### Examples of Sales Prices

**Affordable ownership units are subject to income restrictions at the time of purchase and have deed restrictions that limit the maximum sale price.**

Prices for recent affordable homeownership units are:



- 1 bedroom: \$253,900
- 2 bedroom: \$272,600
- 3 bedroom: \$335,600

### Defining Public Affordable Housing

**Public housing differs from the affordable housing created by private entities in that rents are based on each individual resident's income.**

Public housing is a type of affordable housing that is owned by the federal or state government. Public housing units are owned and managed by Local Housing Authorities (LHA's). The Littleton Housing Authority owns and manages 48 elderly/disabled housing units and 12 units of family housing.

In Massachusetts, waitlist times for state-funded public housing units average around two to four years, particularly for residents with incomes between 30% and 60% of the area median income.<sup>1</sup>

## About

The Scholarship Selection Committee was created by the Trust Fund Commissioners shortly after the 1996 addition of the FM Kimball II Scholarship Fund to the Trust Fund. The Committee was created per the FM Kimball II Trust as “an appropriate group within Littleton with the responsibility of selecting those who are to receive scholarships from the Fund.” With the addition of the John & Eunice Morrison Fund in 2008, the Scholarship Selection Committee is also responsible for nominating scholarship recipients for The Morrison Fund.

The Scholarship Selection Committee consists of (4) Volunteers and (1) member of the Trust Fund Commission. The Volunteers are appointed by the Trust Fund Commissioners. The Scholarship Selection Committee follows the same town policies as any other board or committee within the Town of Littleton.

## Committee Member Roles and Responsibilities

Committee Members individually review and prioritize the Scholarship Applications using the following criteria;

- Academic Achievement
- Communication Skills
- Community Service
- Financial Need

Over multiple committee meetings, the Selection Committee comes to consensus on the list of finalists to be interviewed. After conducting the interviews, the Committee Members generate a recommended list of Annual Scholarship Award recipients, including the distribution of funds. This list is presented to and approved by the Littleton Trust Fund Commission.

Members need to be available for weeknight meetings from mid-March to mid-May. Approximately six meetings lasting about two hours each are used to complete the Scholarship Award process. Members also participate in a Scholarship Award ceremony held in June.

Members must have computer and internet access as the Scholarship Application review is performed using an online format.

## Historical Commission Patriots Day 250th Celebration



The Littleton Historical Commission is excited to announce an expansion of its traditional Patriots Day celebration. The upcoming 250th anniversary of this significant event in American history is Saturday April 19, 2025.

Currently, the Patriots Day celebration takes place annually at 7 p.m. on April 19 at Liberty Square, featuring wreath-laying ceremonies, Taps, a rifle salute by the Boxborough Minutemen, and speeches from the Littleton Historical Commission Chairperson and a Selectboard member. In recognition of the milestone 250th anniversary, we are enhancing this event by moving it earlier in the day, starting mid-morning. The plan includes a procession—potentially featuring police and fire vehicles—to a larger venue, specifically Fay Park, for a town-wide community celebration.

Collaborating with the Littleton Historical Society, and other town organizations, we envision a vibrant town event at Fay Park, complete with activities, entertainment, and food and drink. We would love to see participation from different organizations, students groups, clubs, and societies from in and around Littleton on this day.

Given the anticipated surge of visitors in neighboring towns celebrating the 250th Patriots Day, we believe it is crucial for Littleton residents to have their own event honoring those from our town who fought on that historic day. Fay Park, with its central location, ample parking, and pedestrian-friendly sidewalks, is identified as the ideal venue. Closure of Foster Street from the Historical Society to King Street is proposed to enhance pedestrian movement, particularly near the Historical Society's exhibit on Littleton's involvement in the activities of 1775.

The Littleton Historical Commission has secured \$10,000 in funding from the town to plan and promote this event. Funds can be shared with participating groups to cover expenses associated with participating. A total amount allotted will be determined based on how many groups participate.
