**Fair and Concise Summary:**

as such terms are defined in G.L. c. 94G, §1 and Section 173-2 of the Zoning Bylaw. The Town's current Zoning Bylaw permits the siting and operation of one Marijuana Cultivator and one Craft Marijuana Cooperative, as such terms are defined in G.L. c. 94G, §1 and Section 173-2 of the Zoning Bylaw. Pursuant to G.L. c. 94G, §3, prohibiting any type of marijuana establishment from operating in Town requires (1) a vote of Town Meeting to amend the bylaw to prohibit the use, and (2) a vote of the voters at the ballot approving the amended bylaw. Passage of this ballot question is necessary for any prohibition on the operation of Marijuana Cultivators and Craft Marijuana Cooperatives approved at Town Meeting to take effect.
